DATA CAPTURE MOBILE APP

TARGET TRACK is a full-featured Android mobile application for recording fugitive data during inspections. Data capture categories include:

- Safety management completion of daily hazard assessment form.
- Facility information record details of facility type, equipment/ process list, and contact information.
- Assessment information record details of survey date, technician, and instrument information.
- Component information record details of component service, type, and size for each leak detected.
- Leak information record details of leak description, safety hazard rating, and repair recommendation.

Install TARGET TRACK on any Android device to capture leak data during inspections.



Regardless of whether you have an internally managed program, or you subcontract the inspections to Target Emission Services, all leak data will be uploaded onto TARGET ONLINE management software for you to track repairs, and manage regulatory reporting.


